Students are NOT guaranteed or entitled to any specific parking space. Spaces are available daily on a first come, first served basis. I agree to:

1. Park in the appropriate lot for which I am buying a permit, and only in the "student parking" area.
2. Hang parking permit from the rearview mirror or otherwise clearly displayed and visible from 10+ feet away. Parking without a permit properly displayed will result in a \$10 fine.
3. Drive in a safe manner at all times. Obey the 5 mph speed limit on campus, follow all traffic laws on and around campus, and drive only on paved areas.
4. Check out at the attendance office before leaving campus during school hours.
5. Not have any drugs, alcohol, drug paraphernalia, tobacco, vaporizers, explosives, weapons, or firearms in my vehicle while on campus or within a two-block radius.
6. Submit to a search of my vehicle by an administrator or designee when reasonable suspicion exists.
7. Not access my vehicle at any point during the school day without approval from the main office.
8. Request permission in writing to the main office to transfer a parking permit to a different vehicle. Permits are only transferable to vehicles owned within a family and only valid once the request has been approved and the permit is appropriately displayed.
9. Not vandalize, block, touch, or in any way disturb other people's vehicles.
10. Pay full price to replace a lost parking permit.
11. Report any accidents and/or damage that occurred on campus to the main office within 24 hours.
12. I understand there are no refunds or prorated prices for any reason. All options are listed above.
13. Park oversized vehicles in the Stadium Parking Lot as directed by school staff. This may include, but is not limited to: RVs, trailers, tractors, etc.
14. Seniors who purchase a "Main Lot" pass are eligible to purchase the ability to personalize their spot. See the "Personalized Senior Parking Spots" form for more details

By signing I agree to follow the rules above. I understand that if any of these rules are violated, my pass may be revoked without refund, I may be issued a ticket that will be a fine to my account, and I may be subject to school discipline and/or referral to law enforcement. If I wish to contest a violation, I must notify an administrator within two school days of the violation.
