Dear Student:

The members of Pacific Northwest Grain & Feed Association are pleased to announce our plans to award multiple scholarships **to qualified applicants who are either working for, seeking a career in, or connected to our regional grain and feed industry.**

As the cost of college education continues to increase, obtaining an advanced education is becoming harder to achieve. Our scholarship program is dedicated to helping top students reach their academic potential and career goals, while responding to the financial pressures placed on their families.

To qualify for this award, applicants must be high school seniors, college freshmen and/or sophomores from the Pacific Northwest, who have either been accepted, or are currently enrolled in a 2- or 4-year accredited college or university, and are connected with our grain and feed industry in some way. Previous recipients of the PNWGFA Scholarship are not eligible to apply again. The deadline for applying for these awards is April 7, 2026, so act now!

2026 PNWGFA Scholarship Applications must be postmarked (or electronically dated) no later than April 7, 2026.

The 2026 scholarship application is currently in a PDF fillable format. We hope to publish an online version on www.pnwgfa.org in the future. The onus falls upon the student to ensure **all** required sections are correctly submitted and received by PNWGFA prior to the stated deadline. This includes the Letter of Recommendation. Partial applications will not be considered.

Recipients of the Pacific Northwest Grain & Feed Association Scholarship financial awards will be notified by the end of May 2026 (via phone and/or email). Special recognition to the membership will be given at the 2026 Annual Convention June 15, in Chelan, Washington. Recipients are welcome, but not required, to attend this event.

Instructions:

Following these five steps will improve your chances of being selected as a scholarship recipient:

1. Type or print the application.
2. Complete and return application as soon as possible. The application deadline is **April 7, 2026**.
3. Scholarship awards are based on the applicant's GPA, Work Experience and Leadership Qualities, and **Applicant's Statement**, with a possible total of 100 points. Failure to complete one or more sections of the application will likely disqualify your application. (*See Eligibility and Application Procedure sections below.)
4. Use the space provided, and be as concise as possible. Within reason, additional information may be included on supplemental sheets.
5. Recipients of the scholarship awards will be notified by the Association by the end of May 2026. Funds will be sent to the scholastic institutions in early-to-mid-August. All applicants will receive notification (via email) by mid-summer of the scholarship year.

Eligibility:

1. Applicants must be high school seniors, college freshmen or sophomores from the Pacific Northwest who have either been accepted or are currently enrolled in a 2- or 4-year accredited college or university. (A Student ID number is required for fund distribution.)
2. All candidates must have received a letter of acceptance or be enrolled in an accredited college,
3. Special (additional) consideration may be given to, but not limited to students who have chosen a career in some area of agriculture.
4. Applicants may only be awarded a PNWGFA Scholarship once; previous winners are not eligible.

Application Procedure:

The following **must** be submitted by **April 7, 2026**:

1. Complete Scholarship Application (including all required statement pieces).
- 2. A letter of introduction and recommendation letter.**

Selection Process:

1. The scholarship recipients are selected on the basis of academic record, potential to succeed, demonstrated leadership, extracurricular accomplishments, work experience and an evaluation by a counselor or advisor.
2. All recipients must enter school no later than the fall term following the announcement of the scholarship.

Administrative Procedure:

1. Award checks (with designation letter or form) will be mailed to the college or institution in early-to-mid August. Checks cannot be mailed directly to student.
2. If an awardee changes college or institution, PNWGFA must be notified immediately. If not notified by August 1 of given year, the award may be nullified.
