The Board addressed the pros and cons of Impact Fees and Jim explained the committee recommendations on an M&O/Technology Levy. Student Director, Cynthia Torres provided information on the need of technology upgrades at the schools. The Board discussed options for timelines of bonds to update the high school and plan for a future new elementary school. It was recognized by the Board through the comments at the meeting that safety is being successfully addressed both in building security and Social Emotional Learning (SEL). The Board addressed recommendations of adding space to current common areas at existing school buildings.
