- On May 13<sup>th</sup> Lynden Academy 5<sup>th</sup> graders took a field trip to Olsen Creek Seed Orchard for an opportunity to attend the Earth Science Forest Tour. It's a hands-on learning tour to experience the forest that supports us.
- Lynden Academy is hosting their Share Fair/Field Day tomorrow, June 7th. The students will have a chance to display a poster board on a topic of interest and then in the afternoon we will have crafts and games set up.
- The three elementary schools will be hosting their annual Family Fun Nights at the end of the school year. This is a great opportunity to celebrate the learning and achievements of our youngest learners.
- The Lynden High School CTE Department nominated Mason Namminga as their top choice for the Phyllis Lawson Scholarship awarded by the Washington Association of Career & Technical Administrators. He was then selected as one of the top 4 finalists in the state for his contributions to the CTE program at LHS.
- Two Lynden teachers were nominated by community members for the first-ever Brown & Brown Excellence in Education Award. Vossbeck TK teacher, Meagan Shelley, and LHS Agriculture Teacher, Bria Henthorn, were both honored at the May 22nd ice cream social as finalists.
- Fisher Elementary wrapped up data reviews last week. This is an intense week-long process that analyzes student growth and provides highlights on where improvement is needed. The Fisher Team is looking forward to keeping the momentum going into the next school year.
- Spring sports have come to an end. Congrats to the following teams and individuals:
  - Four Lynden golfers competed in the state tournament- Jack Stapleton (9th), Crew Price (20th), Kinsley Rector (20th) and Lucy Jones (33rd).
  - Boys and Girls Track competed in the state tournament with the girls earning 3rd as a team. This is the first top-four trophy in school history. Lynden also placed in various individual events with Sloan Dickson earning an individual state title in the 800m.
  - Girls Fastpitch advanced to the state quarterfinals and went 2-2 overall at the state tournament capping off a successful season.
  - Lynden Girls Tennis took 3rd as a team in the state tournament, led by a 3rd place individual finish in singles by Anna Samoukovic and a 4th place finish by the doubles team of Kalanie & Rilanna Newcomb.
  - Boys Baseball dropped its semifinal game Friday, but rebounded on Saturday to defeat Anacortes and earn 3rd place in the state tournament.
