Tim Doering, Principal of Isom Elementary School, presented the board with a progress update related to Isom's School Improvement Plan. Their first goal for this year is for 75% of Isom students to be proficient on the STAR reading fluency assessment. At the beginning of the year, 47% of Isom students were proficient. Winter scores showed growth toward goal at 60%. Isom's second goal is that 85% of students will attend regularly by the end of 23/24. At the beginning of year, 75% of students were attending regularly. As of the end of April just over 90% attending regularly.

Ian Freeman, Principal of Lynden High School, presented the board with a progress update related to LHS's School Improvement Plan. Their first goal for this year is that all teachers at LHS will increase understanding and use of UDL as measured by self-assessment surveys in spring 2024. Principal Freeman explained the steps that have taken place so far to reach this goal. Their second goal is to create and implement Tier 1, 2, and 3 systems of academic support to positively impact student success in classes as measured by semester grades with a goal of <15% of D and F grades. Semester 1 had a 13.9% D/F rate.
