Project Hope, a Lynden-based food bank helps provide food for people at their immediate point of need. They work to provide food and assistance to our community and serves families living within the Lynden School District.
 - Lynden Middle School took 15 student leaders to a leadership conference in Anacortes on February 26th. LMS students partnered with student leaders from other schools to exchange ideas, explore servant leadership, and participate in teambuilding activities. Students left loaded with new ideas and energized for action to continue building a positive school climate and culture at LMS.
 - Two Lynden FFA Agricultural Issues teams presented to the Mt. Baker Rotary as part of the students' contest preparations. The
 Washington State FFA State Convention will be held in Pullman from May 8-10. The Lynden FFA will be taking 51 students to
 compete in roughly 14 different contests ranging from Agricultural Communications to Parliamentary Procedure and beyond.
 In addition, there are four other state teams consisting of 20 students whose state contests are held outside of Pullman.
